



# Terms & Conditions

# Terms & Conditions

1. **Rental Agreement** By renting any furniture or equipment from any of our centre under the Forum Group ("the Centre"), the renter ("the Renter") agrees to comply with and be bound by the following terms and conditions.
2. **Rental Items** The items available for rent at each Centre are as listed above, subject to availability. The Centre reserves the right to add or remove items from the rental list at its discretion.
3. **Rental Period** The rental period begins when the Renter takes possession of the rental items and ends when the items are returned to the Centre. All rental items must be returned by the agreed-upon date and time. Late returns will incur additional charges.
4. **Rental Fees** Rental fees are determined based on the type and quantity of items rented and is chargeable on a per-use basis. The Renter must pay the rental fees in full by the due date to secure the rental items.
5. **Security Deposit** A security deposit may be required at the discretion of the Centre. This deposit is refundable, provided that all rental items are returned on time and in good condition. Deductions may be made from the deposit for any damages or missing items.
6. **Condition of Rental Items** All rental items are provided in good working condition. The Renter is responsible for inspecting the items upon receipt and notifying the Centre immediately of any damages or defects. Failure to do so implies acceptance of the items in their current condition.
7. **Use of Rental Items** The Renter agrees to use the rental items solely for their intended purpose and in a careful and proper manner. The Renter is responsible for ensuring that all individuals using the rental items are aware of and comply with these terms and conditions.
8. **Damage or Loss** The Renter is responsible for any damage to or loss of the rental items during the rental period. The Renter agrees to reimburse the Centre for the cost of repair or replacement of any damaged or lost items.
9. **Liability** The Centre is not liable for any injuries, damages, or losses resulting from the use of the rental items. The Renter agrees to indemnify and hold harmless the Centre, its employees, and agents from any claims, damages, or expenses arising out of the use or misuse of the rental items.
